

# Proposed Fee Schedule for Borough of Delaware Water Gap

**The following permit fees are due at issuance of permit:**

## **Administrative:**

Service fee on all return checks	\$28.75
Purchase Zoning Code Book	\$34.50

## **Public Hearings:**

Any application or request requiring a public hearing, and not otherwise specified herein or contained in another Borough Fee Schedule, shall require a fee of

\$575.00\*

\* plus an additional fee of \$575.00 for each additional hearing day after the first hearing day. Additional expenses and Stenographer fees will be the responsibility of the Applicant. Each additional fee shall be due and owing, and shall be paid no later than ten (10) days prior to each respective additional hearing day, or the application fee shall be considered unpaid.

## **Zoning Use and Occupancy Fees:**

2. Single/Multi Family Dwelling – included living space, garage, basements, decks, and covered porches.	\$0.17/sf plus \$57.50

5. Other than residential Accessory Structures (over 200 sf)	\$0.17/sf plus \$80.50
6. Certificate of Non-Conformity	\$80.50
7. Resale Use & Occupancy, Commercial (includes one inspection)	\$230.00

9. Demolition	\$80.50
10. Above Ground Pools	\$115.00
• Wading Pools of 24 inches in depth or less, no permit is required	
11. In-ground Pools	\$115.00 (+.17/ sf)

\* plus an additional fee of \$575.00 for each additional hearing day after the first hearing day. Additional expenses and Stenographer fees will be the responsibility of the Applicant. Each additional fee shall be due and owing, and shall be paid no later than ten (10) days prior to each respective additional hearing day, or the application fee shall be considered unpaid.

**Zoning Applications before Borough Council:**

Conditional Uses and Curative Amendments \$575.00\*

\* plus an additional fee of \$575.00 for each additional hearing day after the first hearing day. Additional expenses and Stenographer fees will be the responsibility of the Applicant. Each additional fee shall be due and owing, and shall be paid no later than ten (10) days prior to each respective additional hearing day, or the application fee shall be considered unpaid.

**Subdivision and Land Development:**

Major/Minor Subdivision Plan (Sketch, Preliminary, Preliminary/Final, Final Submissions)

Application Filing Fee:	\$1,500.00 plus \$115.00 per EDU/dwelling unit/lot
Escrow*:	\$2,000.00 per lot, max \$30,000

Major/Minor Land Development (Sketch, Preliminary, Preliminary/Final, Final Submissions)

Application Filing Fee:	\$1,500.00 plus \$57.50 per property acre
Escrow*:	\$5,000.00 per lot, max \$30,000
