The Flex Connect is a weekday service with selected stops. A reservation is needed, prior to date of trip. The Violet and Yellow Flex service connects to the Red Route at Eagle Valley and the Stroud Mall.

Delaware Water Gap is on the Yellow Route.

Step 1: Register and Reserve Your Ride

Registration is easy and can be done at the same time you need to make a reservation. Call (570) 839-8210 x 1 to speak with a representative between 8:00 AM and 4:30 PM Monday through Friday, by noon the business day before you want to travel. They will help you register and take your reservation.

Happy Summer DWG! I hope everyone is safe and healthy. As you know Friday, June 19th the county moved into the green phase which allowed most businesses to open on a limited basis. We are being told that the virus infection rates have slowed dramatically which is great news, but we should still be cautious and aware that there could be a second wave in the fall. So how has COVID 19 affected our Borough? As for now all major functions in the Gap have been cancelled. This includes Founders Day, Dog Days in the Park, Jazz Fest and so on. Also the Dutot Museum is closed this year which is unfortunate as it is their 50th year anniversary. This is the first time that all these events have been canceled together. It is my sincere hope that we will make up for it next year. One positive note during the shutdown is something that always seems to shine in DWG which is a giving heart. Mike and Elvi DeLotto formed a group known as the Neighbor Program and it was our own meals on wheels so to speak for Gap residents. For 50 days they made meals and with a group of volunteers delivered meals to our residents in need. Donations came in as soon as the program started with the first major donation from Aleks Trucking. I would also like to recognize Jody Reynolds for supplying homemade bake goods for each meal every day. This is what it truly means to live in DWG, and we thank everyone that participated in the program. You may have noticed a stronger police presence on the weekends. Since the shutdown people flooded to the national parks which is great, but they did not comply with the Borough's parking ordinance on Mountain Road essentially closing the road. Our police came in to manage the parking and ticket violators. I also asked them to issue temporary no parking signs to the residents on Mountain Road to prevent people from parking in their yards. 

Local History Spot By Marty Wilson

Crime: DWG

In a previous post on this page the 1868 murder of Theodore Brodhead was described. Thankfully crimes as vicious as that one do not often happen here in our peaceful village. Lesser crimes, however, are another matter. The Dutot Museum recently acquired a collection of court records that lists infractions committed in Delaware Water Gap between 1938 and 1952. They range from the mundane to the tragic. Taken together, the court records offer us a glimpse of one side of life in our town at the middle of the last century.

The names of borough landmarks, many of them businesses long gone, are mentioned in the pages of the records. The Delawanna Inn, the Glenwood, the Cherry Valley Inn, the Hauf Brau Hotel, and the Deer Head Inn were scenes of numerous cases of "drunk and disorderly" behavior. In 1952, two men were arrested at the Hauf Brau Hotel, one for impersonating a police officer and the other for impersonating an FBI agent. In 1951, a man committed an indecent assault on a six-year-old girl at the Delawanna Inn. She was playing on the porch when a man approached her, placed his hand on her, and asked her to go for a walk in the woods with him. She ran from the man and hid behind a door to the dining room where friends of the family found her. In 1948, some men were arrested for trespassing on Island Park, the grounds of the Water Gap Rod and Gun Club.

There are several violations of dog registration and game laws listed. One man was fined \$18 when his dog killed some wild rabbits in 1940. Another, in 1938, was fined \$20 for fishing in Cherry Creek using a spear, which, according to the records, was an illegal method of fishing. In another case, a man was arrested who was "in possession or control [of] the meat and the hide of a deer, said hide not having the head attached in a natural way." He was, apparently, poaching.

Perhaps the largest category of infractions found in the records pertains to operating motor vehicles under the influence of alcohol, or "intoxicating liquor," as it's described in the entries. Some of these cases of drunken driving led to tragic outcomes. At 10:20 on the night of November 19, 1944, a man driving an International truck and trailer ran off the road onto the sidewalk in front of the Water Gap Garage "and did slay and kill Henrietta R. Copenhaver while operating said motor vehicle." A local doctor declared the driver of the truck drunk.

In October of 1937, one Francis Rutty was driving his truck toward Stroudsburg in second gear when, near the Water Gap Cemetery, he "felt a jar and his truck stopped." When Francis checked the rear of his truck he found a Chevrolet had crashed into it. The driver of the Chevrolet was sitting on the running board of the car; an 88-year-old man and a 57-year-old woman were dead in the front seat, killed by the crash. The driver was drunk

Perhaps the saddest story in the court documents involves an automobile crash at the Point of the Gap in 1939. Around 7:30 on the night of July 1 a car traveling at a high rate of speed side-swiped one car before crashing into a second. In the back seat of the second car a mother was holding her infant daughter on her lap (this was before the days of seat belts). The baby was killed instantly. The driver of the car that caused the crash was unconscious. A witness to the crash put him in a car to take him to the hospital, but he regained consciousness as the car neared the traffic light in Water Gap. The man, obviously inebriated, became belligerent and struck the person trying to help him. A police officer subdued him and took him to the hospital where it was determined that he was drunk, but otherwise uninjured.

While these incidents happened some 80-odd years ago, I have not included the names of the defendants out of respect for their families who may still be living in the area.

The Dutot Museum is closed this summer because of the pandemic, but anyone wishing access to the museum to see this, or any of our artifacts, is welcome to contact me.
